Ensure resident's safety and welfare by creating and maintaining a humane environment that encourages recovery and preparation for self-sufficiency. 3. Provide Substance Use Disorder treatment to clients; conduct intake, assessment, orientation, treatment planning, case management, intervention, counseling and teach client education in accordance with DSHS regulations Maintain accurate documentation of all required client contacts in client file and CaseWorthy. Secure files. 4. Work with other staff and agencies to ensure treatment continuum for clients and provide appropriate referrals when specialized care is needed. 5. Supervise resident' self-administration of medication in accordance with DSHS and New Hope policies as needed. 6. Administer Urinalysis and forward results to program manager and relevant staff. 7. Implement and supervise events for residents. Transport program residents in Star of Hope vehicles to off-site activities as needed. 8. Complete and submit reports on time. 9. Obtain and maintain all required licenses and certifications. 10. Monitor and perform require Case-Worthy duties. 11. Maintain regular contact with the Manager of Program Services. 12. Maintain a case load of ten (10) clients, report to work on time and work your assigned schedule.
